Whereas, DURING THE FALL OF 1980, HE COMMENCED FULL-TIME EMPLOYMENT AS AN INSTRUCTOR AT EL CAMINO COLLEGE IN TORRANCE, CALIFORNIA, WHERE HE TAUGHT FOR 18 YEARS (1980-1998), RISING TO THE RANK OF FULL PROFESSOR OF BUSINESS ADMINISTRATION; AN EVALUATION FROM THAT TIME UNDERSCORES HIS LAUDATORY INSTRUCTION; AND

Whereas, BETWEEN 1977 AND 2004, BURTON FLETCHER SHARED HIS EXPERTISE BY TEACHING BUSINESS AND LAW TO MORE THAN 10,000 STUDENTS FOR THIRTEEN INSTITUTIONS OF HIGHER LEARNING: AMERICAN INTERCONTINENTAL UNIVERSITY, ARGOSY UNIVERSITY, CHAFFEY COLLEGE, CITRUS COLLEGE, CYPRESS COLLEGE, EL CAMINO COLLEGE, IVY TECH STATE COLLEGE, LAKE CITY COMMUNITY COLLEGE, LOS ANGELES SOUTHWEST COLLEGE, NORTHWOOD UNIVERSITY, SANTA MONICA COLLEGE, WEBSTER UNIVERSITY, AND WEST LOS ANGELES COLLEGE; AND









Chairman of the Board
